**Summit / Park Junior Card Usage**

- **Cards are non-transferable, non-refundable and valid through the 2020 season only.**
- Valid Sunday through Friday anytime and after 12pm on Saturday.
- Junior Add-On Card is valid only after 4pm or during organized junior events, or anytime as a standby.
- Saturday morning tee times require an additional fee of \$15.00 per round.
- Motorized cart rental is required before 1pm on Saturdays and Sundays.

**Reservation Policy**

- Tee times may be made four days in advance on a space available basis.
- Tee times are accepted online, by telephone, or in person at the golf shop.
- A maximum of two foursomes may be booked per phone call or in person.
- Tee times for organized club programs, may be booked per program guidelines.
- Tee times must be cancelled 24 hrs in advance of the tee time.

**JUNIOR CARDHOLDERS MUST COMPLY WITH ALL GOLF COURSE POLICIES, INCLUDING BUT NOT LIMITED TO THE FOLLOWING:**

- Exhibit proper golf course etiquette at all times
- Follow all tee time policies (making/arrival/cancellations)
- Maintain proper pace of play
- Replace divots, rake bunkers and repair ball marks on greens
- Operation of motorized carts requires a valid driver's license
